

General rules and regulations for the Immunology Quiz

1. Eligibility: This quiz is open only to those who sign up at the <https://quiz.typeform.com/to/d8ocpG5A> and who are **18 years +** as of the date of entry. Employees of Ardigen, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the quiz. The quiz is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

The entry must fulfill all quiz requirements, as specified, to be eligible to win a prize. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Ardigen.
